WHEREAS, these funds have been appropriated for the Workforce Investment Act Youth Funds from the State of Georgia Department of Labor, and the said ordinance was adopted by the Atlanta City Council on September 17, 2007 and approved by the Mayor on September 24, 2007; and

WHEREAS, ordinance 07-O-1654 identified the incorrect center numbers in Section 1 entitled "Add To Appropriations"; and

WHEREAS, the Department of Finance and the Atlanta Workforce Development Agency are in agreement with the ordinance being corrected to reflect the correct center numbers.
