

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

A ORDINANCE AMENDING THE 2007 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE (“DEPARTMENT”), BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE MILLION ONE HUNDRED NINETY SIX THOUSAND SEVEN HUNDRED TEN DOLLARS (\$1,196,710.00) FOR ACCEPTING A JUSTICE ASSISTANCE GRANT FROM THE UNITED STATES DEPARTMENT OF JUSTICE TO ENHANCE THE CRIMINAL JUSTICE SYSTEM IN THE ATLANTA AREA, AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the “City”) applied for a Justice Assistance Grant through the United States Department of Justice for funds to enhance the criminal justice system in the Atlanta area ; and

WHEREAS, in response to the City’s application, the Atlanta Police Department received a grant award in the amount of one million one hundred ninety six thousand seven hundred and ten dollars (\$1,196,710.00); and

WHEREAS, as a condition of the grant, the United States Department of Justice requires that a portion of the award be allocated to Fulton County; and

WHEREAS, consistent with the terms of the grant award, the City allocated three hundred fifty nine thousand and thirteen dollars to Fulton County.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the 2007 (Intergovernmental Grant Fund) Budget, Department of Police and Non-Departmental is hereby amended as follows:
