AMENDMENTS

1. In the second **RESOLVE** Section, amend the words "English Avenue Community Development Corporation" to "**English Avenue Neighborhood Association**".

2. **To add a new, third RESOLVE Section and re-number the old third RESOLVE Section to the fourth RESOLVE Section. The new, third RESOLVE Section shall read:**

"BE IT FURTHER RESOLVED, that if the greenspace option is exercised, said greenspace project shall meet the minimal City's greenspace criteria and guideline and follow the City's formal process of greenspace acquisition."

A RESOLUTION AUTHORIZING THE MAYOR OR HER DESIGNEE TO ENTER INTO A CONTRACTUAL AGREEMENT WITH THE GREATER VINE CITY OPPORTUNITIES PROGRAM IN AN AMOUNT NOT TO EXCEED \$100,000.00, FOR THE IMPLEMENTATION OF PROJECTS TO REHABILITATE ENGLISH AVENUE ELEMENTARY SCHOOL AND NEW GREENSPACE IN THE ENGLISH AVENUE COMMUNITY, UNDER THE 2007 BUDGET OF THE WESTSIDE TAD FUND FROM FUND ACCOUNT AND CENTER NUMBER 1B09 ***
*****; AND FOR OTHER PURPOSES.**

WHEREAS, The Greater Vine City Opportunities Program, has been selected under the 2007 Budget of the Westside TAD Fund grants; and

WHEREAS, funding shall not be released until acquisition of land for either of two options - the rehabilitation of English Avenue Elementary School or new greenspace for the English Avenue Community; and

WHEREAS, the City of Atlanta ("City") wishes to enter into a contractual agreement with The Greater Vine City Opportunities Program, for implementation of the proposed project options in an amount not to exceed \$100,000.00; and

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or her designee be and is hereby authorized to enter into a contractual agreement with The Greater Vine City Opportunities Program, in an amount not to exceed \$100,000.00 for either of two options, to be charged to and paid from Fund Account and Center number 1B09 *****.

BE IT FURTHER RESOLVED, that the **English Avenue Neighborhood Association** and Neighborhood Planning Unit L must endorse either of the proposed projects before funds are released to The Greater Vine City Opportunities Program. If either of the proposed projects fails to materialize, alternative projects must be presented to and approved by the **English Avenue Neighborhood Association**, Neighborhood Planning Unit L, and the Atlanta City Council District 3 office.

BE IT FURTHER RESOLVED, that if the greenspace option is exercised, said greenspace project shall meet the minimal City's greenspace criteria and guideline and follow the City's formal process of greenspace acquisition.

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare the appropriate contractual agreement for execution by the Mayor or her designee.

BE IT FINALLY RESOLVED, that said contractual agreement shall not become binding upon the City, and the City shall incur no liability upon the same until such contract is approved by the City Attorney as to form, executed by the Mayor or her designee, attested to by the Municipal Clerk, and delivered to the contracting parties.
