1. Enterprise Foundation

Clara Axam gave a brief presentation on the Enterprise Community Partners organization, which has been operating in Atlanta since 1992 and has invested \$150 million in Atlanta in the form of grants, loans and equity to rebuild communities and create affordable housing. Ms. Axam stated that the most visible project in Atlanta has been the Mechanicsville Community Learning Collaborative. Enterprise has provided \$12 million in grants in the Mechanicsville Neighborhood through a grant. The organization has worked with community based organizations to provide services that will get people ready to enter the workforce. The Mechanicsville Community Learning Collaborative is a comprehensive model that is now being replicated in various cities throughout the country.




