AN ORDINANCE ADOPTING THE OLD FOURTH WARD REDEVELOPMENT PLAN UPDATE BY REFERENCE INTO THE 2008 ATLANTA STRATEGIC ACTION PLAN OF THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has conducted the Old Fourth Ward Redevelopment Plan Update for the area bounded by Ponce de Leon & North Avenue to the north, Dekalb Avenue to the south, the Beltline corridor to the east, and Piedmont Avenue & Boulevard to the West in the City of Atlanta; and

WHEREAS, the residents and property owners in NPU M worked with the Bureau of Planning Staff and a consultant team led by Tunnell, Spangler, Walsh & Associates to develop a vision for the future transportation and land use functions of the area, in conjunction with desirable residential, office, commercial and employment growth; and

WHEREAS, this planning document entitled the *Old Fourth Ward Redevelopment Plan Update* has been developed based upon the direct input of the residents, property/business owners and other stakeholders in the study area; and

WHEREAS, the City Council wishes to adopt said plan as a guide for future development.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:

Section 1. That the Old Fourth Ward Redevelopment Plan Update, a copy of which is attached hereto as Exhibit "A", is hereby adopted as a component of the 2008 Atlanta Strategic Action Plan by the City Council of the City of Atlanta, Georgia.

Section 2. That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
