

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING THE 2007 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FIVE HUNDRED FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$550,000.00) FOR A GRANT AWARD THE UNITED STATES DEPARTMENT OF JUSTICE, TO ASSIST IN COMBATTING ILLEGAL GANGS AND NARCOTICS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) applied for a grant from the United States Department of Justice (“DOJ”), for a funds to be used to in conjunction with other programs to combat violent crime and gang activity; and

WHEREAS, in response to the City’s application, Department has received a grant award in the amount of five hundred fifty thousand dollars and zero cents (\$550,000.00) from the DOJ, to combat illegal gangs and narcotics; and

WHEREAS, the grant money will help curtail drug trafficking and its harmful consequences in the City; and

WHEREAS, the funding will also assist in the implementation of the Atlanta Police Department’s gang reduction program.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2007 (Intergovernmental Grant Fund) Budget, Department of Police is hereby amended as follows:


