THE NEW SECTION 5 READS AS FOLLOWS:

SECTION 5: THAT THE BUREAU OF TRAFFIC AND TRANSPORTATION
WILL ALLOW THE HILLS AVENUE STREET NAME SIGNS TO REMAIN
FOR SIX (6) MONTHS FROM THE DATE OF INSTALLATION OF THE
NEW SIGNS.

WHEREAS, Hills Avenue NW, from Defoor Hills Road, NW to Chattahoochee Avenue NW, appears to be a continuation of Collier Rd. NW; and

WHEREAS, it would be less confusing to motorists and the general public, if the name of that part of Hills Avenue were changed to Collier Rd. NW so that the continuation of the street name of Collier Rd. NW would logically coincide with the continuation of the roadway.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That Hills Ave., NW, from Defoor Hills Rd., NW to Chattahoochee Ave., NW, be re-named Collier Rd., NW (Map attached).

SECTION 2: That Section 138-8 (b) Application Procedure of the Code of Ordinances of the City of Atlanta is hereby waived for this instance only.

SECTION 3: That this legislation be transmitted to the affected Neighborhood Planning Units for informational purposes as required by Section 2-2 of the Code of Ordinances.

SECTION 4: That the Municipal Clerk is hereby directed to notify the United States Postal Services and all other affected agencies.

SECTION 5: That the Bureau of Traffic and Transportation will allow the Hills Avenue Street name signs to remain for six (6) months from the date of installation of the new signs.

SECTION 6: That all Ordinances and parts of Ordinances in conflict herewith are hereby waived in this instance only.

Section 3: That this legislation be transmitted to the affected Neighborhood Planning Units for informational purposes as required by Section 2-2 of the Code of Ordinances.

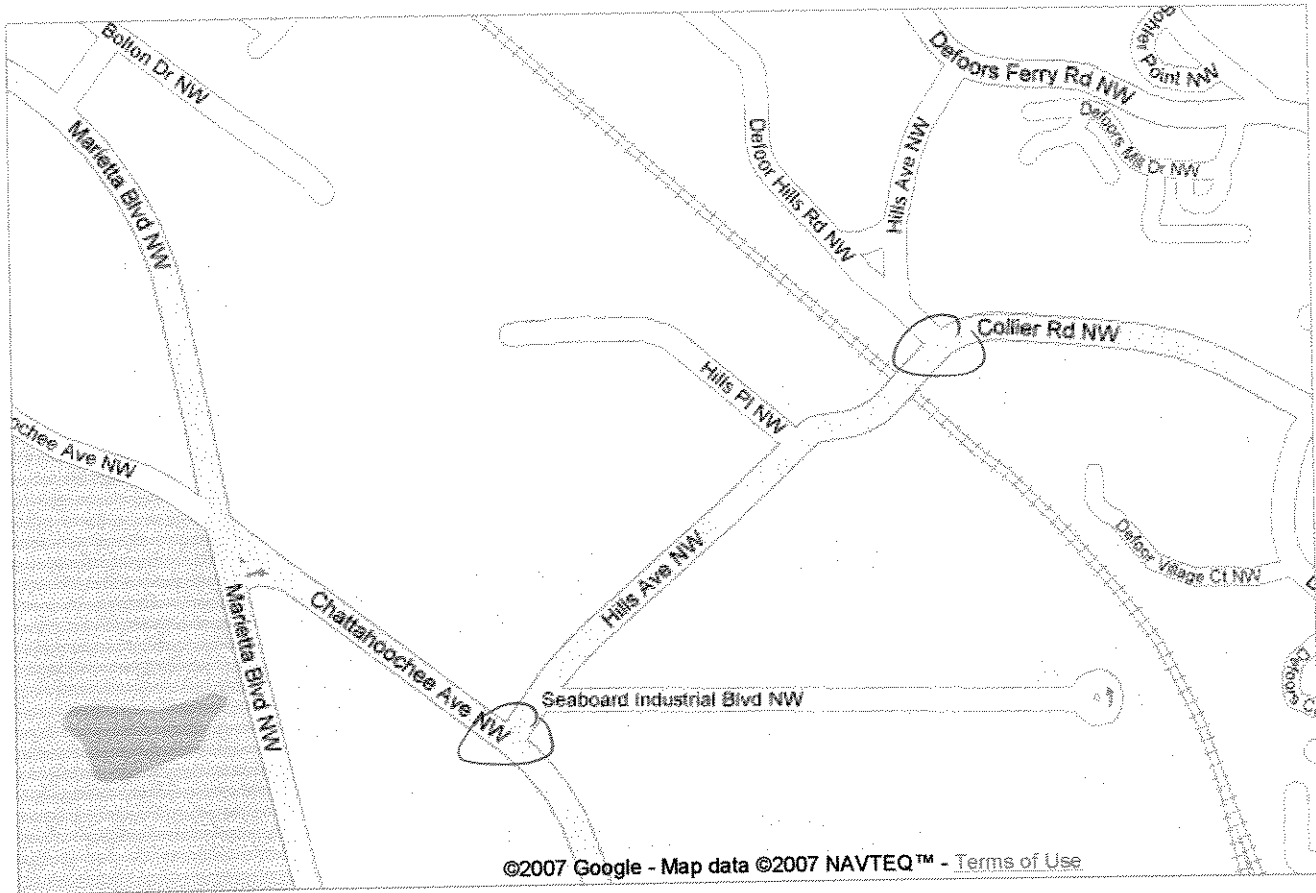

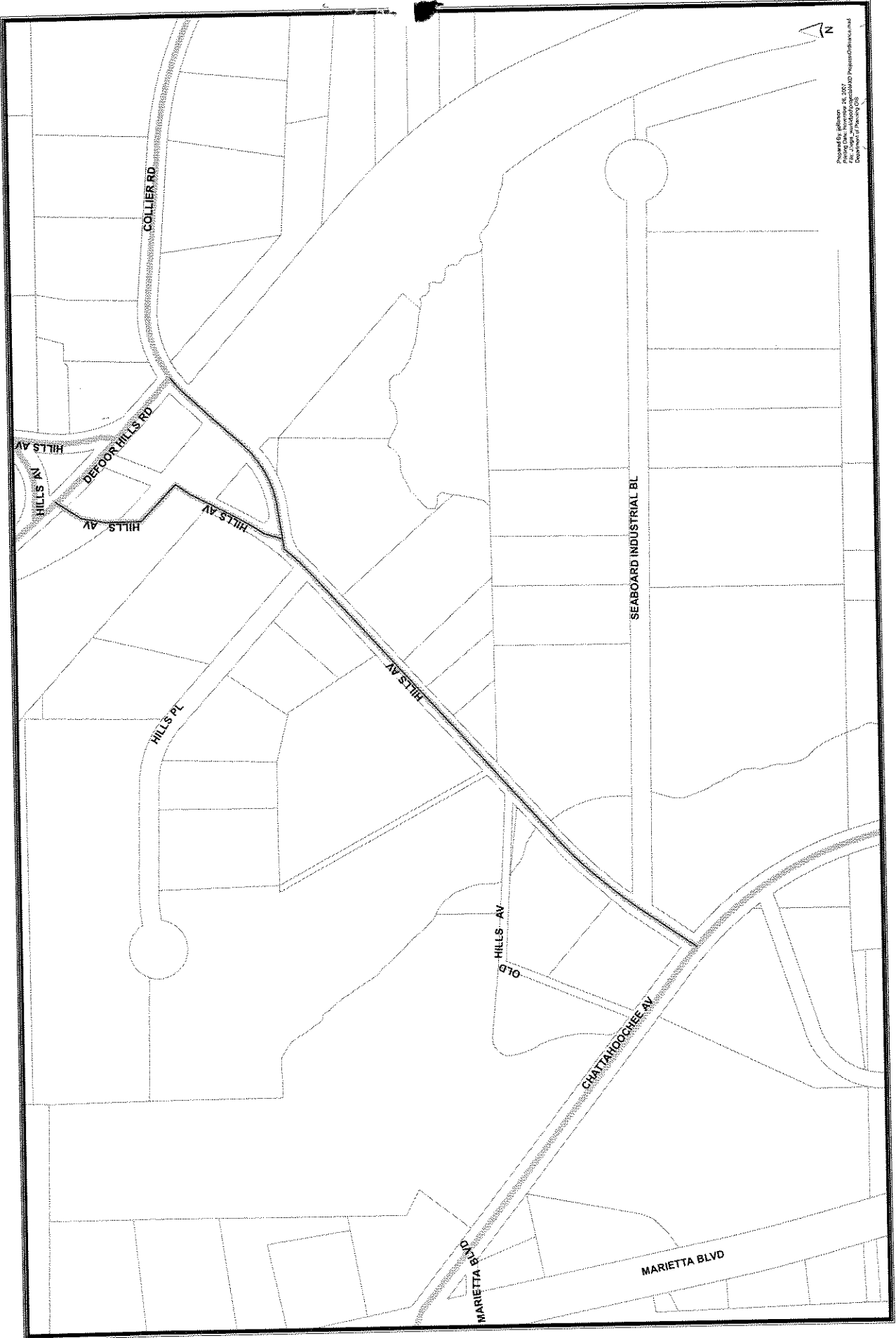
