

**AN ORDINANCE BY  
COMMUNITY DEVELOPMENT AND HUMAN RESOURCES COMMITTEE**

**AN ORDINANCE TO AMEND PART 6, CHAPTER 4, ARTICLE A, SECTION 6-4001(a) OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, GEORGIA, LAND DEVELOPMENT CODE, ENTITLED "CREATION AND COMPOSITION", SO AS TO CHANGE THE NUMBER OF VOTING MEMBERS ON THE ATLANTA PLANNING ADVISORY BOARD FROM TWENTY FOUR (24) VOTING MEMBERS TO TWENTY FIVE (25) VOTING MEMBERS; AND FOR OTHER PURPOSES.**

**WHEREAS**, upon petition by residents of the Midwest Cascade area, on September 29, 2006 and pursuant to ordinance 06-O-1932, the City of Atlanta ("City") annexed said area into its corporate limits; and

**WHEREAS**, since that time the City has been providing municipal services to the Midwest Cascade residents; and

**WHEREAS**, the annexation of Midwest Cascade area has created the need for a new Neighborhood Planning Unit (NPU) Q; and

**WHEREAS**, the creation of the new NPU-Q requires that the Atlanta Planning Advisory Board be changed from twenty four (24) voting members to twenty five (25) voting members.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:**

**Section 1:** That Part 6, Chapter 4, Article A, Section 6-4001 (a) of the Code of Ordinances of the City of Atlanta, Georgia, Land Development Code, which reads:

- (a) There is hereby created the Atlanta Planning Advisory Board which shall be Composed of 24 voting members.

Is hereby amended to read as follows"

- (a) There is hereby created the Atlanta Planning Advisory Board which shall be Composed of 25 voting members.

**Section 2:** That all existing ordinances or parts of ordinances in conflict with this ordinance shall be waived for the purposes of this Ordinance only, and only to the extent of the conflict.
