

**AN ORDINANCE BY

AN ORDINANCE TO RESTRICT LEFT TURN MOVEMENT FROM 14TH STREET WESTBOUND ONTO PEACHTREE STREET SOUTHBOUND AND TO RESTRICT RIGHT TURN ON RED MOVEMENT FROM 14TH STREET WESTBOUND ONTO PEACHTREE STREET NORTHBOUND; AND FOR OTHER PURPOSES.

WHEREAS, left turn movement from 14th Street westbound onto Peachtree Street southbound will improve traffic movement at the intersection of 14th Street and Peachtree Street; and

WHEREAS, a field investigation reveals that restriction of right turn on red movement from 14th Street westbound onto Peachtree Street northbound will benefit heavy pedestrian traffic using the intersection; and

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1: That left turn traffic movement from 14th Street westbound onto Peachtree Street southbound shall be prohibited

SECTION 2: That right turn on red traffic movement from 14th Street westbound onto Peachtree Street northbound shall be prohibited.

SECTION 3: All ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
