**AN ORDINANCE BY

**AN ORDINANCE AUTHORIZING THE INSTALLATION OF TWO (2) HOUR PARKING SIGNS ALONG WEST PEACHTREE STREET, N.W., BETWEEN NORTH AVENUE AND PEACHTREE PLACE, FOR THE PURPOSE OF ESTABLISHING UNIFORM PARKING; AND FOR OTHER PURPOSES.**

**WHEREAS**, West Peachtree Street, N.W., between North Avenue and Peachtree Place has recently undergone a sidewalk reconstruction and installation. The area also has experienced redevelopment, which includes retail establishments and residential housing; and

**WHEREAS**, 30 minute, 1 hour, and 2 hour parking signs currently exist in locations along West Peachtree Street, N.W.; and

**WHEREAS**, the City of Atlanta desires to establish uniform parking along West Peachtree Street, N.W. by installing two (2) hour parking signs along West Peachtree Street N.W., between North Avenue and Peachtree Place.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:**

**SECTION 1:** That two (2) hour parking signs be installed along West Peachtree Street, N.W., between North Avenue and Peachtree Place, for the purpose of establishing uniform parking.

**SECTION 2:** All ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
