**AN ORDINANCE AUTHORIZING THE INSTALLATION OF ALL-WAY STOP  
SIGNS AT THE INTERSECTION OF KINGS GRANT DRIVE N.W. AND

**WHEREAS**, the City of Atlanta (“City”) received a request to make the intersection of Kings Grant Drive N.W. and Eleanor Terrace (“Intersection”) an all-way stop; and

**WHEREAS**, the City performed a traffic study and field investigation of the aforesaid intersection; and

**WHEREAS**, the analysis and field investigation revealed that visibility at the intersection is limited; and

**WHEREAS**, the City recommends the installation of all-way stop signs at the intersection of Kings Grant Drive N.W. and Eleanor Terrace.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY  
ORDAINS as follows:**

**SECTION 1:** That the intersection of Kings Grant Drive N.W. and Eleanor Terrace be made an all-way stop.

**SECTION 2:** All ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
