AN ORDINANCE AMENDING THE 2007 (JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY (“AWDA”), BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWO HUNDRED FORTY FIVE THOUSAND FIVE HUNDRED SIXTY FOUR DOLLARS (\$245,564) IN THE WORKFORCE INVESTMENT ACT (“WIA”) DISLOCATED WORKER PROGRAM, FOR GRANT FUNDS FROM THE GEORGIA DEPARTMENT OF LABOR (“GDOL”); AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the WIA is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the occupational skill attainment of participants, thereby improving the quality of the workforce, reducing welfare dependency, and enhancing the productivity and competitiveness of the nation; and

WHEREAS, the GDOL awarded AWDA a grant in the amount of two hundred forty five thousand five hundred sixty four dollars (\$245,564.00), for the grant period beginning 7/1/2007 and ending on 6/30/2009, to fund the Dislocated Worker Fund; and

WHEREAS, the AWDA recommends increasing receipts in the 2007 (Job Training Fund) by \$245,564.00 in the Dislocated Worker Fund.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2007 Dislocated Worker Job Training Fund Budget for the AWDA is hereby amended as follows:
