AN ORDINANCE AMENDING THE 2007 (JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY ("AWDA"), BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000.00) IN THE WORKFORCE INVESTMENT ACT ("WIA") NATIONAL EMERGENCY GRANT FUNDS TO PROVIDE JOB TRAINING AND EMPLOYMENT OPPORTUNITIES FOR CLIENTS AFFECTED BY HURRICANE KATRINA, FROM THE GEORGIA DEPARTMENT OF LABOR ("GDOL"); AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the WIA is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the occupational skill attainment of participants, thereby improving the quality of the workforce, reducing welfare dependency, and enhancing the productivity and competitiveness of the nation; and

WHEREAS, the GDOL awarded AWDA a grant in the amount of one hundred twenty thousand dollars (\$120,000), for the grant period beginning 6/30/2007 and ending on 6/30/2008, to fund job training and employment opportunities for clients affected by hurricane Katrina; and

WHEREAS, the AWDA recommends increasing receipts in the 2007 (Job Training Fund) by \$120,000.00 in the National Emergency Grant (Katrina) Fund.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

**SECTION 1:** That the 2007 National Emergency Grant Fund Budget for the AWDA is hereby amended as follows:
