

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING THE 2008 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF SEVENTY FIVE THOUSAND EIGHT HUNDRED EIGHTY DOLLARS AND ZERO CENTS (\$75,885.00) FOR AN EXPLOSIVE ORDINANCE DISPOSAL (EOD) EQUIPMENT GRANT FROM THE GEORGIA EMERGENCY MANAGEMENT AGENCY (GEMA) FOR THE PURPOSE OF PURCHASING EQUIPMENT FOR BOMB INVESTIGATIONS RELATED TO HOMELAND SECURITY FOR THE DEPARTMENT OF POLICE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”), Department of Police (“Department”), applied for an Explosive Ordinance Disposal (EOD) equipment grant from the Georgia Emergency Management Agency (GEMA), for a funds to purchase equipment for the purpose of bomb investigations related to Homeland Security; and

WHEREAS, in response to the City’s application, the Department has received an EOD grant award from the Georgia Emergency Management Agency in an amount not to exceed seventy five thousand eight hundred eighty five dollars and zero cents (\$75,885.00) to purchase equipment for the purpose of bomb investigations related to Homeland Security; and

WHEREAS, the EOD grant money will increase the Department’s effectiveness of response to bomb investigation issues related to Homeland Security; and

WHEREAS, the EOD funding will also assist in the implementation of the Department’s Homeland Security bomb investigation program.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2008 (Intergovernmental Grant Fund) Budget, Department of Police is hereby amended as follows:
