**AN ORDINANCE TO ANTICIPATE AND APPROPRIATE AN AMOUNT OF FIFTY EIGHT THOUSAND SIX HUNDRED AND SIXTY SIX DOLLARS (\$58,666) FROM THE CRIMINAL JUSTICE COORDINATING COUNCIL FOR THE PURPOSE OF CONTINUING THE PROVISION OF A RESTORATIVE BOARD IN THE ENGLISH AVE/VINE CITY AREA OF ATLANTA**

**WHEREAS**, the Community Court Division of the Municipal Court has been notified that it has been awarded a one-year grant from the Criminal Justice Coordinating Council (CJCC) for the purpose of continuing the provision of a restorative board in the English Ave/Vine City area of Atlanta, which has been previously funded, and

**WHEREAS**, this funding will provide effective sentencing alternatives for non-violent, low-level offenders in the English Ave/Vine City area of Atlanta; thereby, preventing future crimes and reducing recidivism, and

**WHEREAS**, this funding will strengthen neighborhoods and close the gap between the courts and community by educating citizens about restorative board values and processes, and

**WHEREAS**, this funding will provide necessary resources to implement identified alternative sentencing programs.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:**
