

**AN ORDINANCE

AN ORDINANCE AMENDING THE 2008 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF NINETY SIX THOUSAND DOLLARS AND NO CENTS (\$96,000.00), FOR A GRANT AWARD FROM THE ATLANTA REGIONAL COMMISSION FOR THE VINE CITY MARTA TRANSIT AREA LCI STUDY; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) participates in the Livable Communities Initiative (LCI) program sponsored by the Atlanta Regional Commission (“ARC”); and

WHEREAS, the City has received notification from the ARC that the City will receive a 2008 grant award in the amount of Ninety Six Thousand Dollars and No Cents (\$96,000.00) to fund the Vine City Marta Transit Area LCI Study; and

WHEREAS, the City desires to accept the grant award, and anticipate and appropriate grant funds in the amount of Ninety Six Thousand Dollars and No Cents (\$96,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the Mayor is hereby authorized to execute a Grant Agreement with the Atlanta Regional Commission, in the amount of \$96,000.00, for the Vine City MARTA Transit Area LCI Study.

SECTION 2: That the 2008 (Intergovernmental Grant Fund) Budget, Department of Planning and Community Development, is hereby amended as follows:
