AN ORDINANCE BY COUNCIL MEMBER CLAIR MULLER

AN ORDINANCE AUTHORIZING THE INSTALLATION OF “NO PARKING” AND “NO PARKING EXCEPT SUNDAYS” SIGNS ALONG KINGSWOOD LANE BETWEEN NORTHSIDE DRIVE AND NORMANDY DRIVE, QUEENSBURY LANE FROM ITS TERMINUS TO KINGSWOOD LANE, AND NORTHSIDE DRIVE AT ITS INTERSECTION WITH KINGSWOOD LANE; AND FOR OTHER PURPOSES.

WHEREAS, property owners along Kingswood Lane and Queensbury Lane have a difficult time navigating their streets with vehicles parked on both sides of the streets; and

WHEREAS, vehicles parked on both sides of the streets is creating concern for the ability of emergency vehicles to traverse the streets; and

WHEREAS, vehicles parking on Sunday in the right-turn deceleration lane along Northside Drive creates a less safe condition and contributes to poor operation of the Northside Drive and Kingswood Road intersection; and

WHEREAS, there is general parking now available in the Northside United Methodist Church parking deck; and

WHEREAS, the Northside United Methodist Church desires to provide convenient accessibility for handicap and elderly citizens; and

WHEREAS, the affected property owners and the Northside United Methodist Church leaders have approved a parking plan; and

WHEREAS, the affected property owners have signed a petition giving their support for the plan; and

WHEREAS, the City of Atlanta Department of Public Works has reviewed and is in support of the plan.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

Section 1. That the Mayor through the Department of Public Works, Office of Transportation shall implement the following:

- a) Designate the northbound right-turn deceleration lane along Northside Drive at its intersection with Kingswood Lane as “NO PARKING”, in coordination with Georgia Department of Transportation since Northside Drive is a state route.

- b) Designate the north side of Kingswood Lane, from Northside Drive to the North North Atlanta High School access as “NO PARKING EXCEPT SUNDAYS.”
- c) Designate the north side of Kingswood Lane, from North Atlanta High School access to Normandy Drive, as “NO PARKING”.
- d) Designate the first 190’ along the south side of Kingswood Lane, from Northside Drive, as “NO PARKING”.
- e) Designate the south side of Kingswood Lane, from the Northside United Methodist Church parking deck access to Normandy Drive, as “NO PARKING EXCEPT SUNDAYS”.
- f) Designate both sides of Queensbury Lane, from its terminus to its intersection with Kingswood Lane, as “NO PARKING”.

Section 2.

That the Department of Public Works, Office of Transportation shall install appropriate signage and striping (as outlined in the plan agreed to by the property owners, Northside United Methodist Church leaders with appropriate changes deemed necessary by the Department of Public Works, Office of Transportation.

Section 3.

All ordinances or parts of other ordinances in conflict herewith are waived for purposes of this ordinance only, and only to the extent of the conflict.
