

**SUBSTITUTE ORDINANCE BY
COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

ORDINANCE AMENDING ORDINANCE 08-O-0635, ADOPTED BY CITY COUNCIL MAY 5, 2008 AND APPROVED BY THE MAYOR MAY 13, 2008, AND 08-O-1358, ADOPTED BY CITY COUNCIL AND APPROVED BY THE MAYOR JULY 21, 2008 BY CORRECTING VARIOUS ORACLE PROJECT NUMBERS; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 08-O-0635, adopted by the City Council on May 5, 2008 and approved by the Mayor on May 12, 2008 contained erroneous Oracle project numbers for various HUD-funded projects; and

WHEREAS, Ordinance 08-O-1358, adopted by the City Council and approved by the Mayor July 21, 2008 contained erroneous Oracle project numbers for various HUD-funded projects; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That Ordinance 08-O-0635, adopted by the City Council adopted on May 5, 2008 and approved by the Mayor on May 12, 2008 be and is amended hereby by changing in Section 8 the Oracle project number from **25210039** to **10210039**.

Section 2: That Ordinance 08-O-1358, adopted by the City Council and approved by the Mayor July 21, 2008 be and is amended hereby as follow:

- a. In Section 1 by changing project name from Atlanta Children’s Shelter to Atlanta Enterprise Center and by adding:

- b. In Section 2 by changing the Oracle project number for 818 Pollard Boulevard Accessibility from **07110109** to **04110305** and by correcting the allocation of **Award 220130082**, from **\$200,000.00** to **\$10,242.00**.
- c. In Section 3 by changing the Oracle project number for Bankhead Redevelopment from **13101770** to **25202266**.
- d. By adding a new Section 7 to reads as follows: That Section 6 of Ordinance 08-O-0636, adopted by City Council on May 5, 2008 and approved by the Mayor on May 12, 2008 be amended to correct the allocation for project number 10210166 Municipal Market Section 108 Loan Repayment, GO Bond Interest Payment from **\$117,186.00** to **\$117,276.00**.

- e. By adding a new Section 8 to reads as follows: That Section 15 of Ordinance 08-O-0636, adopted by City Council on May 5, 2008 and approved by the Mayor on May 12, 2008 be amended to correct the allocation for project number 0421013 Living Room from \$1,302,763.00 to \$1,002,763.00; by correcting the allocation for project number 10210041 Program Administration from \$80,261.00 to \$73,320.00 and from \$130,759.00 to \$137,700.00 and by changing the total for the section from \$5,243,726.00 to \$4,943,726.00.
- f. By adding a new Section 9 to reads as follows: That all ordinances and parts of ordinance in conflict with this ordinance are hereby repealed.
