

**A SUBSTITUTE ORDINANCE
BY COMMUNITY DEVELOPMENT/ HUMAN RESOURCES COMMITTEE**

AN ORDINANCE AUTHORIZING THE MAYOR TO ISSUE A NOTICE TO PROCEED TO ARCADIS/BPA, A JOINT VENTURE FOR FC-7619-03A, ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES, REAL ESTATE PROFESSIONAL SERVICES FOR PARKS, GREENSPACE, TRAILS, GREENWAYS, AND CONSERVATION LANDS, ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00); AND AUTHORIZING THE 2008 GENERAL GOVERNMENT CAPITAL OUTLAY FUND BUDGET TO BE AMENDED BY TRANSFERRING ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) TO PROJECT, TASK, AWARD, EXPENDITURE, ORGANIZATION 14101519 103 350291110 5212001 CITY OF ATLANTA AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta did enter into FC-7619-03A, Annual Contract for Architectural and Engineering Services, with Arcadis/BPA, Joint Venture on behalf of the Department of Parks, Recreation and Cultural Affairs; and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs requires real estate services for parks and greenspace acquisitions and donations, conservation and trail easement acquisitions and donations, and real estate tasks associated with the long-term management of acquired properties; and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs and the Chief Procurement Officer have recommended the issuance of a Notice to Proceed for FC-7619-03A to Arcadis/BPA, a Joint Venture, to provide these services to the City of Atlanta.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY
ORDAINS:**

SECTION 1: That the 2008 General Government Capital Outlay Fund Budget is hereby amended as follows:

SECTION 2: That the Mayor is authorized to issue a Notice to Proceed to Arcadis/BPA, a Joint Venture for FC-7619-03A, Annual Contract for Architectural and Engineering Services, Real Estate Professional Services for Parks, Greenspace, Trails, Greenways, and Conservation Lands in an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00), to be paid from Project, Task, Award, Expenditure Organization 14101519 103 350291110 5212001 .

SECTION 3: That the Chief Procurement Officer is hereby directed to prepare an appropriate agreement.

SECTION 4: That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
