

**AN ORDINANCE BY
PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING ORDINANCE NUMBER 08-O-1047 AND AMENDING THE 2007 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS, IN THE AMOUNT OF FOUR MILLION-SIX HUNDRED NINETY THOUSAND-ONE HUNDRED AND NINETY SEVEN DOLLARS (\$4,839,882.00), FOR GRANT FUNDS, FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY, FOR THE PURPOSE OF CONTINUING THE HIGH INTENSITY DRUG TRAFFICKING AREA (“HIDTA”) TASK FORCE; TO DISRUPT DRUG TRAFFICKING ORGANIZATIONS; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Police (“Department”) has been an active participant in the High Intensity Drug Trafficking Area (HIDTA) task force for over the past ten years; and

WHEREAS, the White House Office of National Drug Control Policy (“White House”) grants funding to local task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

WHEREAS, Department serves as the “pass through” agency to disburse payments for task force expenses that are completely federally funded; and

WHEREAS, Ordinance 07-O-1233 amended the 2007 Intergovernmental Grant Fund Budget, Department of Police in the amount of four million, five hundred twenty thousand, and forty-four dollars, (\$4,520,044.00), which was the original amount awarded to the Department by the White House;

WHEREAS, Ordinance 08-O-1047 increased the amount awarded by \$170,153.00 to a total amount of four million, six hundred and ninety thousand, one hundred and ninety-seven dollars (\$4,690,197.00) due to increased funding from the White House; and

WHEREAS, the White House has further increased the amount awarded by \$149,685.00 to a total amount of four million, eight-hundred and thirty-nine thousand, eight-hundred and eighty-two dollars (\$4,839,882.00) to continue funding HIDTA task force initiatives; and

WHEREAS, the Department wishes to accept the said supplemental grant to continue funding the HIDTA task force.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2007 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:
