



AN ORDINANCE

BY COUNCILMEMBER KWANZA HALL

AUTHORIZING THE MAYOR OR HER DESIGNEE TO MAKE BOTH SIDES OF CORLEY STREET FROM A POINT FROM THE INTERSECTION OF JOHN WESLEY DOBBS TO ANOTHER POINT FROM THE INTERSECTION OF JOHN WESLEY DOBBS, NE "NO PARKING ANYTIME"; AND FOR OTHER PURPOSES.

WHEREAS, Corley Street, NE is a narrow (18 feet wide) One-way street between John Wesley Dobbs and Highland Avenue NE; and

WHEREAS, the residence at 638 John Wesley Dobbs Ave. N.E. includes a garage with a driveway entrance on Corley Street, NE; and

WHEREAS, egress from the garage and driveway is virtually impossible if cars are parked on Corley Street; and

WHEREAS, parking is currently prohibited on the west side of Corley Street; and

WHEREAS, there continue to be instances where cars parked on the east side of Corley Street inhibit egress from the residence at 638 John Wesley Dobbs Ave; and

WHEREAS, the owner of the property at 638 John Wesley Dobbs Ave has requested that a portion of Corley Street be designated No Parking on Both Sides; and

WHEREAS, the Department of Public Works recommends that parking on the east side of Corley Street be restricted so as not to interfere with the driveway for the residence at 638 John Wesley Dobbs Ave. N.E.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

SECTION 1: That both sides of Corley Street, NE beginning 155 feet from the intersection of John Wesley Dobbs, NE and ending 185 feet from the intersection of John Wesley Dobbs, NE be designated **"NO PARKING ANY TIME"**.

SECTION 2: That appropriate signage and yellow curbs identifying the affected portion of the street be installed.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
