

**AN ORDINANCE
BY COMMITTEE ON COUNCIL**

AN ORDINANCE TO REDUCE THE PERSONNEL COSTS OF THE OFFICES OF THE MUNICIPAL CLERK, THE DIRECTOR OF COUNCIL STAFF AND COUNCILMEMBERS BY TEN PERCENT (10%); TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, due to the national and local economic downturn, the mayor of the City of Atlanta is projecting a \$50 to \$60 million revenue shortfall for the fiscal 2009 budget; and

WHEREAS, as a result of this projected revenue shortfall, the mayor has imposed a four hour weekly furlough for all general fund employees beginning in December and extending through June, 2009; and

WHEREAS, the city council desires to participate in the reduction of the city's personnel costs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: The city council hereby reduces the personnel costs of the Offices of The Municipal Clerk, The Director of Council Staff and Councilmembers as contained in its fiscal year 2009 budget by ten percent (10%), to be accomplished in the following manner:
