**A RESOLUTION TO CORRECT RESOLUTION NUMBER 08-R-0165 ADOPTED  
BY THE ATLANTA CITY COUNCIL ON FEBRUARY 4, 2008, AND APPROVED  
BY THE MAYOR ON FEBRUARY 12, 2008; AND FOR OTHER PURPOSES.**

**WHEREAS**, Resolution 08-R-0165 was adopted by the Atlanta City Council February 4, 2008 and approved by the Mayor on February 12, 2008; and

**WHEREAS**, Resolution 08-R-0165 authorized the Mayor to execute the first amendment to the contract with Beacon of Hope, Inc., to extend the contract term and add funds to the contract in an amount not to exceed \$80,000, to complete the rehabilitation of four housing units; and

**WHEREAS**, the legislation incorrectly stated the original contract amount as \$92,000, and the new total not to exceed amount of the contract as \$172,000; and

**WHEREAS**, the Department of Planning and Community Development, Bureau of Housing, desires to correct Resolution 08-R-0165, to reflect the correct dollar amount for the original contract as \$92,500, and to reflect the correct total contract amount after the amendment as \$172,500.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES** that Resolution 08-R-0165 is hereby corrected by changing the original contract amount in the legislation from \$92,000 to \$92,500, and by changing the new total not to exceed amount of the contract from \$172,000 to \$172,500.

**BE IT FURTHER RESOLVED**, that all Resolutions and parts of Resolutions in conflict herewith are hereby waived to the extent of the conflict.





