

A RESOLUTION

BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE

A RESOLUTION AUTHORIZING THE CHIEF FINANCIAL OFFICER TO ESTABLISH A TRUST FUND ACCOUNT, ON BEHALF OF THE DEPARTMENT OF CORRECTIONS, FOR THE PURPOSE OF DEPOSITING FUNDS RECEIVED FROM FULTON COUNTY; SAID FUNDS TO BE USED FOR REBUILDING / UPGRADING INFRASTRUCTURE AND INCORPORATING SECURITY ENHANCEMENTS AT THE ATLANTA CITY DETENTION CENTER; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta and Fulton County entered into an agreement that Atlanta City Detention Center would provide 175 total beds to Fulton County jail at a rate of sixty-eight dollars (\$68.00) per day ; and

WHEREAS, on June 19, 2007, Fulton County amended the agreement requesting that Atlanta City Detention Center provide an additional hundred (100) beds for a total of two hundred seventy-five (275) beds at a rate of sixty eight dollars (\$68.00) per day; and

WHEREAS, funds received from Fulton County for the additional one hundred beds will be placed in a trust fund account dedicated to rebuilding/upgrading infrastructure and incorporating security enhancements to the Atlanta City Detention Center.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Chief Financial Officer is authorized to establish a trust fund account for the purpose of depositing funds received from Fulton County to be used for rebuilding/upgrading infrastructure and incorporating security enhancements for the Atlanta City Detention Center.


BE IT FINALLY RESOLVED, that the Chief Financial Officer is further authorized to receive funds into and from this trust account for the purpose set forth herein.
