BUILDING YOUTH LEADERSHIP INITIATIVE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Mayor's Office of Weed and Seed coordinates federal, state and local resources for the purpose of developing comprehensive strategic approaches to law enforcement, community policing, community building and neighborhood restoration; and

**WHEREAS**, the City of Atlanta has been notified of the availability of funding from the State of Georgia targeting youth leadership and civic engagement; and

**WHEREAS**, the City of Atlanta wishes to support the empowerment of youth leadership in partnership with the Pittsburgh Community Improvement Association (PCIA) giving youth the tools to identify and promote constructive organization skills to promote positive solutions in their own neighborhoods.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor is authorized to apply for and accept a grant from the State of Georgia in an amount not to exceed Twenty Thousand Dollars and No Cents (\$20,000.00), for the purpose of promoting youth leadership.

**BE IT FURTHER RESOLVED**, that no matching funds are required for this grant agreement.

**BE IT FINALLY RESOLVED**, that the Mayor is authorized to enter into any necessary grant agreements.
