

**A RESOLUTION BY
PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE MAYOR'S OFFICE OF WEED AND SEED, TO APPLY FOR AND ACCEPT FUNDING IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$150,000.00), FROM THE U.S. DEPARTMENT OF JUSTICE COMMUNITY CAPACITY DEVELOPMENT OFFICE, FOR THE CONTINUATION OF THE WEED AND SEED STRATEGY IN THE VINE CITY COMMUNITY; TO PROVIDE FOR MATCHING FUNDS; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Justice Community Capacity Development Office has funded the Weed and Seed program for the purpose of developing comprehensive strategic approaches to law enforcement, community policing, community building and neighborhood restoration by coordinating federal, state and local resources and;

WHEREAS, the City of Atlanta has been notified of the availability of funding for 2009-10 to support the Weed and Seed strategy; and

WHEREAS, the City of Atlanta wishes to continue the Weed and Seed strategy in the Vine City community.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES, that the Mayor is hereby authorized to apply for and accept a grant from the U.S. Department of Justice Community Capacity Development Office in an amount not to exceed One Hundred Fifty Thousand Dollars and No Cents (\$150,000.00), for the purpose of coordinating, collaborating and leveraging resources targeting the Vine City community.

BE IT FURTHER RESOLVED, that the Mayor is authorized to enter into any necessary grant agreements.

BE IT FINALLY RESOLVED, that this grant will require matching funds in the amount of One Hundred and Fifty Thousand Dollars (\$150,000.00) to support law enforcement, community policing, community building and neighborhood restoration initiatives.
