**A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE MAYOR'S OFFICE OF WEED AND SEED, TO APPLY FOR AND ACCEPT FUNDING IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$250,000.00), FROM THE U.S. DEPARTMENT OF JUSTICE FOR THE INTENSIVE SURVEILLANCE OFFICER PROGRAM; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Mayor's Office of Weed and Seed coordinates federal, state and local resources for the purpose of developing comprehensive strategic approaches to law enforcement, community policing, community building and neighborhood restoration; and

**WHEREAS**, the City of Atlanta wishes to continue the Intensive Surveillance Officer program for the purpose of providing intensive intervention services to children to prevent them from returning to the juvenile court systems; and

**WHEREAS**, the City of Atlanta has been notified of funding from the U.S. Department of Justice, and wishes to continue this program for an additional year.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor is hereby authorized to apply for and accept a grant from the U.S. Department of Justice in an amount not to exceed Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00), for the purpose of managing the Intensive Surveillance Officer Program.

**BE IT FURTHER RESOLVED**, that no matching funds are required for this grant agreement.

**BE IT FINALLY RESOLVED**, that the Mayor is authorized to enter into any necessary grant agreements.
