

**A RESOLUTION

**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF AGREEMENT WITH THE TRANSPORTATION SECURITY ADMINISTRATION TO GRANT APPROVAL FOR USE OF A PARCEL OF LAND AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Transportation Security Administration (“TSA”) has explosives detection canine teams under the TSA Federal Canine Teams and has a requirement to store the TSA-provided canine explosives training aids in a storage magazine at Hartsfield-Jackson Atlanta International Airport (the “Airport”); and

**WHEREAS**, the TSA has requested the right to use a small parcel of land at the Airport and to install a magazine for storage of the training aids; and

**WHEREAS** the TSA wishes to construct a small concrete pad and related safety and security features and will monitor the storage magazine to ensure proper operation and maintenance of the storage magazine; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA**, that the Mayor is authorized to execute on behalf of the City of Atlanta a Memorandum of Agreement with the TSA under which the TSA shall be granted the right to use a parcel of land at the Airport.

**BE IT FURTHER RESOLVED** that the City Attorney be and hereby is directed to prepare said Memorandum of Agreement and any other necessary agreements for execution by the Mayor.

**BE IT FINALLY RESOLVED** that said Amendment will not become binding upon the City of Atlanta, and the City of Atlanta will incur no obligation or liability thereunder until same has been signed by the Mayor and delivered to the Transportation Security Administration.


