

**A RESOLUTION BY**

**PUBLIC SAFETY & LEGAL ADMINISTRATION COMMITTEE**

**AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA, TO EXECUTE TEMPORARY SERVICE CONTRACTS WITH (15) RETIRED CITY OF ATLANTA ("CITY") POLICE OFFICERS, FOR THE PURPOSE OF PROVIDING PROFESSIONAL SECURITY SERVICES AT THE PUBLIC SAFETY HEADQUARTERS FOR A PERIOD OF (1) YEAR, IN AN AMOUNT NOT TO EXCEED ONE-HUNDRED EIGHTY-SIX THOUSAND, ONE-HUNDRED FIFTY DOLLARS (186,150.00). ALL COSTS TO BE CHARGED TO GL String number: 1001.240202.5212001.3260000.000000.0000; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta Public Safety Headquarters is in need of professional security services to screen all customers entering the building; and

**WHEREAS**, retired City Police officers possess the knowledge and expertise to provide the necessary professional security services; and

**WHEREAS**, the Police Department desires to execute temporary service contracts with fifteen (15) retired City police officers for the purpose of providing professional security services at the Atlanta Public Safety Headquarters for a period of one (1) year, in an amount not to exceed One-hundred Eighty-Six Thousand, One-Hundred Fifty Dollars (\$186,150.00); and

**WHEREAS**, one such retired officer shall be designated the supervisor and shall be compensated \$21.73/hour, and the remaining officers shall be compensated at \$19.30/hour; and

**WHEREAS**, such engagements are authorized pursuant to Article 3, Chapter 5, Section 3-505 of the Charter of the City of Atlanta.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES** that they Mayor be and is hereby authorized to execute a contract, on behalf of the City of Atlanta, with fifteen (15) retired Atlanta Police Officers, for the purpose of providing security services at the Atlanta Public Safety Headquarters for a period of 1 year, in an amount not to exceed One-hundred Eighty-Six Thousand, One-Hundred Fifty Dollars (\$186,150.00).

**BE IT FURTHER RESOLVED**, that the City Attorney or his/her designee be and is directed to prepare the Agreement for execution by the Mayor, and the Agreement shall be approved by the City Attorney or his/her designee as to form.

**BE IT FURTHER RESOLVED**, that the Agreement shall not become binding upon the City and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor or his/her designee and delivered to the respective retired City of Atlanta Police Officers.
