AUTHORIZING THE MAYOR OR HER DESIGNEE TO ACCEPT THE DONATION OF STREET SIGN TOPPERS AT THREE INTERSECTIONS ALONG CONTINENTAL COLONY PARKWAY, SW IN RECOGNITION OF THE NEW TYLER PERRY STUDIO; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta is facing economic hardships along with the rest of the country; and

WHEREAS, the old Delta Airlines property located on Continental Colony Parkway in Southwest Atlanta has been vacant for years; and

WHEREAS, one of this country's brightest up and coming author, director and playwright has decided to use this property some twenty-eight (28) acres for his film making and production studio and other endeavors; and

WHEREAS, the development of this property will continue the revitalization cycle this area is experiencing as well as remove some of the blight this property was becoming; and

WHEREAS, this project will bring some three hundred (300) jobs with it as well as much needed tax revenues to the city's coffers as well as a much needed economic boost to the Greenbriar area of Southwest Atlanta.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That the Mayor or her designee is authorized to accept from the Tyler Perry Studio three (3) street sign toppers for the purpose of being installed at the following intersections:

1. **Continental Colony Parkway, SW at Hogan Road, SW**
2. **Continental Colony Parkway, SW at Riviera Drive, SW**
3. **Continental Colony Parkway, SW at Greenbriar Parkway, SW**

SECTION 2: That said signs shall meet the specifications required by the Department of Public Works and installed under their supervision and in accordance to Code Section 138-13.

SECTION 3: The Tyler Perry Studio agrees to cover all costs associated with installation and manufacturing of the sign toppers.

SECTION 4: That all resolutions in conflict herewith are hereby waived for this instance only.

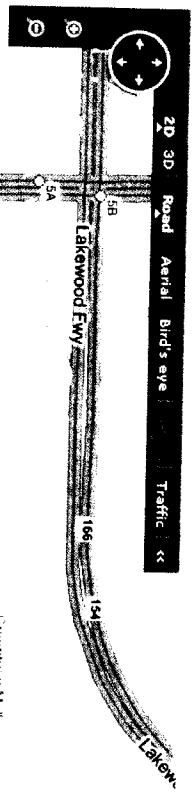

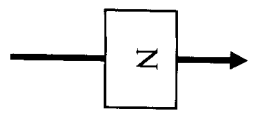
