

**A RESOLUTION
BY TRANSPORTATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF AGREEMENT NO. DTFASO-08-L-00122 WITH THE FEDERAL AVIATION ADMINISTRATION, COVERING NAVIGATIONAL AID FACILITIES AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.

WHEREAS, the Federal Aviation Authority (“FAA”) and the City of Atlanta (“City”) have entered into an Airport Improvement Grant Agreement for Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, City and FAA (“the parties”) consider it desirable to work in cooperation with each other in the technical installation and operation of air navigational aids;

WHEREAS, the parties agree that the establishment, operation, and maintenance of systems for air traffic control, navigation, communication, and weather reporting is in the primary interest of safety and direct support of the ongoing operation of the Airport.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA that the Mayor is authorized to execute on behalf of the City of Atlanta a Memorandum of Agreement (MOA) Number DTFASO-08-L-00122 with the FAA, covering the terms and conditions under which the City will allow the FAA to construct, operate, relocate and maintain FAA owned navigation, communication and weather aid facilities in areas of the Airport that have been mutually agreed upon, for a term commencing November 1, 2008, and continuing until October 31, 2028, unless earlier terminated by the FAA.

BE IT FURTHER RESOLVED that the City Attorney is directed to prepare said MOA for execution by the Mayor, to be approved as to form by the City Attorney.

BE IT FINALLY RESOLVED that the MOA shall not become binding upon the City of Atlanta, and the City of Atlanta shall incur no obligation nor liability thereunder until the same has been signed by the Mayor and delivered to the FAA.


