A RESOLUTION TO EXTEND THE SERVICE DELIVERY STRATEGY (SDS) BETWEEN THE CITY OF ATLANTA AND DEKALB COUNTY UNTIL APRIL 30, 2009; AND FOR OTHER PURPOSES.

WHEREAS, O.C.G.A. § 36-70-21 requires as of July 1, 1999 the adoption of local government Service Delivery Strategy (“SDS”) Agreements between a county and every municipality located wholly or partially within such county; and

WHEREAS, O.C.G.A. § 36-70-27 provides that no state administered financial assistance or grant, loan, or permit shall be issued to any local government or authority which is not included in a State of Georgia Department of Community Affairs (“DCA”) verified SDS or for any project which is inconsistent with such SDS; and

WHEREAS, the City of Atlanta and Dekalb County, Avondale Estates, Chamblee, Clarkston, Decatur, Doraville, Lithonia, Pine Lake, and Stone Mountain have previously participated in the development of a Service Delivery Strategy; and

WHEREAS, the local government Service Delivery Strategy Agreements must be approved by the City of Atlanta and Dekalb County, Avondale Estates, Chamblee, Clarkston, Decatur, Doraville, Lithonia, Pine Lake, and Stone Mountain; and

WHEREAS, O.C.G.A. § 36-70-25 provides that the approval of the Service Delivery Strategy shall be accomplished by the adoption of a Resolution:

- A. By the county governing authority;
- B. By the governing authority of each city within the county which has a population of 9,000 or greater within the county;
- C. By the city which serves as the county seat; and
- D. By no less than 50% of the remaining cities which have a population of at least 500 persons within the county; and

WHEREAS, the adopted Service Delivery Strategy must be verified by the State of Georgia Department of Community Affairs (“DCA”); and

WHEREAS, 07-R-1482 extended the existing SDS Agreements between the City of Atlanta and Dekalb County and the aforementioned municipalities for a period of one year ending on October 31, 2008; and

WHEREAS, the failure of the City of Atlanta to extend the existing SDS Agreement beyond October 31, 2008 may result in the loss of state administered financial assistance or grant, loan, or permit; and

WHEREAS, Dekalb County and the other aforesaid municipalities within Dekalb County have requested an extension in which to submit their comprehensive plan updates; and

WHEREAS, the City of Atlanta and Dekalb County and the other aforesaid municipalities within Dekalb County have agreed to extend the existing SDS Agreement until April 30, 2009.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES that the existing Service Delivery Strategy Agreement between the City of Atlanta and the aforesaid municipalities and Dekalb County shall be renewed and remain in full force until April 30, 2009.
