

**A RESOLUTION BY
PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A LEASE RENEWAL AGREEMENT WITH ASI PROPERTIES, INC. ON BEHALF OF THE ATLANTA POLICE DEPARTMENT, FOR THE RENTAL OF 5,026 SQUARE FEET OF OFFICE SPACE LOCATED AT 3120 MAPLE DRIVE, ATLANTA, GEORGIA, FOR THE DEPARTMENT OF POLICE ZONE TWO PRECINCT AT A RENTAL RATE OF \$89,714.10 PER YEAR, TO BE CHARGED TO AND PAID FROM 1001.240406.5223103.3223000; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Police currently occupies 5,026 square feet of office space at 3120 Maple Drive, pursuant to a lease agreement between ASI Properties, Inc., and the City of Atlanta; and

WHEREAS, the current lease agreement provides for a one-year renewal from 1 February 2009, until 31 January 2010, at a rental rate of \$89,714.10 for the year; and

WHEREAS, the Department of Police desires to continue occupying 3120 Maple Drive for use as the Police Zone Two Precinct.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor be and is hereby authorized to enter into the additional renewal term of the lease agreement with ASI Properties, Inc. on behalf of the Atlanta Police Department, for the lease of 5,026 square feet of office space located at 3120 Maple Drive, Atlanta, Georgia, for the Department of Police Zone Two Precinct, from 1 February 2009 until 31 January 2010, at a rental rate of \$89,714.10 for the year, to be charged to and paid from **1001.240406.5223103.3223000**.

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to review the lease agreement prior to execution by the Mayor.

BE IT FINALLY RESOLVED, that the agreement shall not be binding upon the City and the City will incur no obligation or liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, and attested to by the Municipal Clerk.
