**WHEREAS**, the City of Atlanta (“City”) has undertaken capital improvement projects at Hartsfield-Jackson Atlanta International Airport (“Airport”); and

**WHEREAS**, the City entered into a Contract No. FC-3007000037-B (“Contract”), Small Business Managing General Contractor, with Biosphere International, Inc (“Biosphere”), pursuant to Resolution 08-R-0421; and

**WHEREAS**, the Department of Aviation requires environmental abatement services and the Aviation General Manager has determined that it is desirable and in the City’s best interest to assign this project to Biosphere, to include services relating to Wynterbrook Apartments.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ATLANTA, GEORGIA**, that the Aviation General Manager or his designee is authorized to issue Task Orders to Biosphere in an amount not to exceed \$250,000.00, pursuant to Code Section 2-1111.
