A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO VARIOUS CONTRACTUAL AGREEMENTS FOR THE IMPLEMENTATION OF PROJECTS UNDER COMMUNITY DEVELOPMENT BLOCK GRANT-RECOVERY (CDBG-R) OF THE AMERICAN RECOVERY AND REINVESTMENT ACT (ARRA) OF 2009; AND FOR OTHER PURPOSES

WHEREAS, the projects adopted by the City Council and approved by the Mayor under the Community Development Block Grant-Recovery (CDBG-R) Program of the American Recovery and Reinvestment Act (ARRA) of 2009 and are ready for implementation; and

WHEREAS, these projects have obtained the necessary environmental clearances from the U.S. Department of Housing and Urban Development and are ready for implementation; and

WHEREAS, the City has obtained release of funds from the U.S. Department of Housing and Urban Development (HUD) for these projects, based on the filing of environmental clearances.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Mayor or her designee be and is authorized hereby to enter into contractual agreements for the following Community Development Block Grant-Recovery (CDBG-R) projects:
