

## AN ORDINANCE

## BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE

AN ORDINANCE AMENDING THE 2009 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FORTY-THOUSAND, SIX-HUNDRED FIFTY EIGHT DOLLARS AND SEVENTY-TWO CENTS (\$40,658.72), FOR GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF JUSTICE BULLETPROOF VEST PARTNERSHIP IN THE AMOUNT OF TWENTY-THOUSAND, THREE-HUNDRED TWENTY-NINE DOLLARS AND THIRTY-SIX CENTS (\$20,329.36) AND MATCHING FUNDS IN THE AMOUNT OF TWENTY-THOUSAND, THREE-HUNDRED TWENTY-NINE DOLLARS AND THIRTY-SIX CENTS (\$20,329.36) FROM THE GENERAL FUND BUDGET, AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Justice (“DOJ”) has awarded the Atlanta Police Department twenty-thousand, three-hundred twenty-nine dollars and thirty-six cents (\$20,329.36) for the purchase of new body armor for Atlanta Police Officers to be matched with twenty-thousand, three-hundred twenty-nine dollars and thirty-six cents (\$20,329.36) from local funds; and

WHEREAS, the Atlanta Police Department (“Department”), wishes to use these grant funds to provide a high level of safety to its sworn-officers through the purchase of state-of-the-art bullet-proof vests; and

WHEREAS, the grant matching funds of twenty-thousand, three-hundred twenty-nine dollars and thirty-six cents (\$20,329.36) will be charged to a portion of the department’s 2009 budget at GL String number 1001.240201.5710001.3210000.000000.0000.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**
