

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING THE 2009 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWO-HUNDRED THIRTY-TWO THOUSAND, FIVE-HUNDRED DOLLARS AND ZERO CENTS (\$232,500.00) FOR A GRANT AWARD FROM THE GOVERNOR'S OFFICE OF HIGHWAY SAFETY AND MATCHING FUNDS IN THE AMOUNT OF NINETY-THREE THOUSAND DOLLARS (\$93,000) FROM THE GENERAL FUND BUDGET, TO FUND THE HIGHWAY ENFORCEMENT OF AGGRESSIVE TRAFFIC; AND FOR OTHER PURPOSES.

WHEREAS, the Governor's Office of Highway Safety provides grants to promote safety on the roadways; and

WHEREAS, the City of Atlanta Police Department applied for and received two-hundred thirty-two thousand, five hundred dollars and zero cents (\$232,500.00) in grant funds from the Governor's Office of Highway Safety; and

WHEREAS, the grant matching funds of ninety-three thousand dollars and zero cents (\$93,000.00) will be charged to a portion of the department's 2009 budget at GL String number 1001.240201.5710001.3210000.000000.0000.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2009 (Intergovernmental Grant Fund) Budget, Department of Police is hereby amended as follows:
