

**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

A ORDINANCE AMENDING THE 2009 (INTERGOVERNMENTAL GRANT FUND), BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF THREE-HUNDRED SEVENTY-THREE THOUSAND, THREE-HUNDRED AND FIFTY-NINE DOLLARS (\$373,359.00) FOR ACCEPTING A JUSTICE ASSISTANCE GRANT FROM THE UNITED STATES DEPARTMENT OF JUSTICE TO ENHANCE THE CRIMINAL JUSTICE SYSTEM IN THE ATLANTA AREA, AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City") applied for a Justice Assistance Grant through the United States Department of Justice for funds to enhance the criminal justice system in the Atlanta area ; and

WHEREAS, in response to the City's application, the Atlanta Police Department received a grant award in the amount of three-hundred seventy-three thousand, three-hundred fifty-nine dollars and zero cents (\$373,359.00); and

WHEREAS, as a condition of the grant, and in accordance with 08-R-1259, adopted by Council on July 7, 2008 and signed by the Mayor on that same day, One-hundred twelve thousand, seven dollars and seventy cents (\$112,007.70) of the award shall be allocated to Fulton County; and

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the 2009 (Intergovernmental Grant Fund) Budget, Department of Police and Non-Departmental is hereby amended as follows:
