AN ORDINANCE TO AMEND SECTION 6-302(a) OF THE CODE OF THE CITY OF ATLANTA SO AS TO DELAY THE SUBMISSION AND ADOPTION OF A RESOLUTION OF COUNCIL BUDGET PRIORITIES UNTIL THE SECOND MEETING IN MARCH FOR THE 2010 BUDGET; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta in the process of planning the 2010 Budget; and

WHEREAS, before a true picture of the City's financial situation can be obtained, the City's FY 2008 Close Out as part of the Comprehensive Annual Financial Report (CAFR) for FY 2008 must be completed; and

WHEREAS, the Chief Financial Officer projects that the FY 2008 Close Out and CAFR will not be complete before January 31, 2009; and

WHEREAS, the members of City Council should have this information prior to considering possible priorities for the FY 2010 Budget; and

WHEREAS, Council receipt of this information in February 2009 will not allow members sufficient time to review and digest the information before the submission of the Council Budget Priorities resolution by the second Council meeting in February as required by Section 6-302 (a) of the Atlanta City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1:

Section 6-302, subsection (a) of the Code of the City of Atlanta shall be amended for the FY 2010 Budget only by changing all February references to March.

SECTION 2:

All ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this ordinance only, and only to the extent of the conflict.
