

**AN ORDINANCE BY

**AN ORDINANCE AMENDING THE 2009 (JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE MILLION FOUR HUNDRED THREE THOUSAND TWENTY ONE DOLLARS (\$1,403,021.00) IN THE WORKFORCE INVESTMENT ACT ADULT FUND, FROM THE GEORGIA DEPARTMENT OF LABOR, IN ORDER TO FUND THE WIA ADULT PROGRAM; AND FOR OTHER PURPOSES.**

**WHEREAS**, the purpose of the Workforce Investment Act ("WIA") is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the occupational skill attainment or participants, thereby improving the quality of the workforce; and

**WHEREAS**, the Georgia Department of Labor ("GDOL") has awarded the Atlanta Workforce Development Agency ("AWDA") a grant in the amount of One Million Four Hundred Three Thousand Twenty One Dollars (\$1,403,021.00), to fund the WIA Adult Program and provide training funds for Adults who need to upgrade or acquire job skills to obtain full-time employment at liveable wages; and

**WHEREAS**, the AWDA recommends increasing receipts in the 2009 (Job Training Fund) Budget by One Million Four Hundred Three Thousand Twenty One Dollars (\$1,403,021.00) in the WIA Adult Fund.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:**
