**AN ORDINANCE TO AMEND THE 2009 INTERGOVERNMENTAL GRANT FUND BUDGET, EXECUTIVE OFFICES, MAYOR’S OFFICE OF WEED AND SEED, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$380,098 FROM THE DEPARTMENT OF JUSTICE BYNE DISCRETIONARY GRANT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Edward Byrne Memorial Discretionary Grants Program administered by the Office of Justice Programs’ (OJP’s) Bureau of Justice Assistance (BJA), helps improve the capacity of local adult criminal justice systems and provides for national support efforts such as training and technical assistance projects to strategically address local needs; and

**WHEREAS**, the City of Atlanta Safe III project will target offenders with children known to the juvenile justice system, and seek to reduce the recidivism of adult ex-offenders in a multi-jurisdictional partnership; and

**WHEREAS**, the City of Atlanta has been notified of funding and wishes to implement the initiative.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:**

**Section 1:** That the 2009 Intergovernmental/Grant Fund Budget be and is amended as follows:




