

**AN ORDINANCE BY
COUNCILMEMBER CLETA WINSLOW
AS SUBSTITUTED BY TRANSPORTATION COMMITTEE**

**AUTHORIZING THE MAYOR OR HER DESIGNEE TO REMOVE
PARKING RESTRICTION FROM THE EAST SIDE OF PRYOR
STREET, S. W. BETWEEN FULTON STREET AND GLENN STREET;
AND FOR OTHER PURPOSES**

WHEREAS, the Pryor Street corridor in the Mechanicsville area has experienced a residential growth spurt resulting in the need for additional on street parking; and

WHEREAS, the residents are concerned that visitors and friends vehicles are being towed at an alarming rate due to a lack of parking; and

WHEREAS, no parking lots or metered parking exist along this corridor for use by the public; and

WHEREAS, the citizens of Atlanta; in general, and the Pryor Street community specifically, would benefit greatly along with the public's safety enhanced if a parking lane is installed; and

WHEREAS, removal of parking restriction will have a positive impact on this neighborhood and all citizens of Atlanta will benefit.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA; as follows:

SECTION 1: That the Mayor or her designee (Department of Public Works) is authorized to remove parking restriction from the east side of Pryor Street, SW between Fulton Street, S.W. and Glenn Street, S.W.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived to the extent of the conflict.

STREET, SW AND RICHARDSON STREET, SW;
AND FOR OTHER PURPOSES.**

WHEREAS, the Pryor Street corridor in the Mechanicsville area has experienced a residential growth spurt resulting in the need for additional on street parking; and

WHEREAS, the residents are concern that visitors and friends vehicles are being towed at an alarming rate due to a lack of parking; and

SECTION 1: That the Mayor or her designee (Department of Public Works) is authorized to install a parking lane on Pryor Street, SW between Fulton Street, SW and Richardson Street, SW.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived to the extent of the conflict.
