**AN SUBSTITUTE ORDINANCE AUTHORIZING THE MAYOR OR HER DESIGNEE, ON BEHALF OF THE CITY, TO ACCEPT A GRANT FROM THE ATLANTA REGIONAL COMMISSION FOR THE D.L. HOLLOWELL/VETERANS MEMORIAL PARKWAY CORRIDOR LIVABLE CENTER'S INITIATIVE (LCI) PROJECT IN THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND DOLLARS AND NO CENTS (\$120,000.00); ANTICIPATING AND APPROPRIATING THE GRANT FUNDS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") participates in the Livable Center's Initiative (LCI) program sponsored by the Atlanta Regional Commission ("ARC"); and

**WHEREAS**, the Bureau of Planning was authorized pursuant to Resolution 08-R-2173 to make application for the D.L. Hollowell/Veterans Memorial Parkway Corridor LCI Project; and

**WHEREAS**, this project is a collaborative study between the City of Atlanta and Cobb County to promote new smart growth development along the D.L. Hollowell/Veterans Memorial Parkway Corridor,

**WHEREAS**, the City has received notification from ARC that the City has been selected for a grant award in the amount of One Hundred Twenty Thousand Dollars and No Cents (\$120,000.00) to fund the D.L. Hollowell/Veterans Memorial Parkway Corridor LCI Project; and

**WHEREAS**, the D.L. Hollowell Parkway Memorial LCI Study requires matching funds of twenty-percent in the amount of Thirty Thousand Dollars (\$30,000.00) ; and

**WHEREAS**, said match will be provided by Cobb County (\$15,000.) and by District Nine Quality of Life funds Award 313821776, Account 5414002 (\$15,000.);

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:**

**Section 1.** That the Mayor, or her designee, on behalf of the City of Atlanta, is authorized to accept a grant from Atlanta Regional Commission in the amount of One Hundred Twenty Thousand Dollars (\$120,000.00) for the purpose of conducting a LCI Study along the D.L.
