A SUBSTITUTE ORDINANCE AMENDING THE 2009 (JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE MILLION SEVENTY EIGHT THOUSAND NINETY SEVEN DOLLARS (\$1,078,097.00) IN THE WORKFORCE INVESTMENT ACT ADULT FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULTS; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act (“WIA”) is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the occupational skill attainment of participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Department of Labor (“GDOL”) has awarded the City of Atlanta (“City”), through the Atlanta Workforce Development Agency (“AWDA”), a grant in the amount of One Million Seventy Eight Thousand Ninety Seven Dollars (\$1,078,097.00), to provide training funds for adults who need to upgrade or acquire skills to obtain full-time employment at liveable wages; and

WHEREAS, AWDA recommends increasing receipts in the 2009 (Job Training Fund) Budget by One Million Seventy Eight Thousand Ninety Seven Dollars (\$1,078,097.00) in the WIA Adult Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2009 WIA (Adult Job Training Fund) Budget is hereby amended as follows:
