A SUBSTITUTE ORDINANCE AMENDING THE 2009 (JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWO MILLION SEVEN HUNDRED FORTY-FOUR THOUSAND NINETY-ONE DOLLARS (\$2,744,091.00) IN THE WORKFORCE INVESTMENT ACT YOUTH FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO AREA YOUTH; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act (“WIA”) is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the occupational skill attainment of participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Department of Labor (“GDOL”) has awarded the City of Atlanta (“City”), through the Atlanta Workforce Development Agency (“AWDA”), a grant in the amount of Two Million Seven Hundred Forty-Four Thousand Ninety One Dollars (\$2,744,091.00), to provide job training and other skills to area youth; and

WHEREAS, AWDA recommends increasing receipts in the 2009 (Job Training Fund) Budget by Two Million Seven Hundred Forty-Four Thousand Ninety One Dollars (\$2,744,091.00) in the WIA Youth Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2009 WIA (Youth Fund) Budget is hereby amended as follows:
