AN ORDINANCE AMENDING THE 2009 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF THREE MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND THREE HUNDRED SEVENTEEN DOLLARS AND NO CENTS (\$3,988,317.00) UNDER THE STATE OF GEORGIA DEPARTMENT OF COMMUNITY AFFAIRS (DCA) NEIGHBORHOOD STABILIZATION PROGRAM (NSP); AND FOR OTHER PURPOSES

WHEREAS, the City of Atlanta has been awarded \$3,988,317.00 from the State of Georgia Department of Community Affairs (DCA) to implement the NSP; and

WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the 2009 (Intergovernmental Grant Fund) Budget by \$3,988,317.00.
