WHEREAS, the City of Atlanta is required by the Georgia Comprehensive Solid Waste Management Act of 1990 to reduce 25% of its waste stream; and

WHEREAS, the City of Atlanta is doing its part with the collection of municipal solid waste which it is responsible for collecting along with its recycling program but has not reached the mandated goal of a 25% reduction according to the City of Atlanta's Solid Waste Management Plan Update (2005); and

WHEREAS, the Recycling and Yard Trimmings Services assists the City in achieving state waste reduction goal of 25% and serves as a method of waste stream diversion; and

WHEREAS, members of the Atlanta City Council have expressed concerns with the current program and have ideas on how this program can be more efficient and effective in the future.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or her designee (Commissioner of Public Works and/or Chief Procurement Officer) is authorized to submit a copy of any Request for Proposal (RFP) for Recycling and Yard Trimmings Services to the City Council prior to this service (Recycling and Yard Trimmings Services) being advertised.

AND FINALLY BE IT REOLVED, that all resolutions and parts of resolutions in conflict herewith be and the same are hereby waived to the extent of the conflict.
