**AN ORDINANCE TO ANTICIPATE AND APPROPRIATE TSA GRANT FUNDS IN THE AMOUNT OF \$20,000,000 FROM THE TRANSPORTATION SECURITY ADMINISTRATIONS' (TSA) TO REIMBURSE THE CITY 90% FOR ALLOWABLE COST OF THE DESIGN, MANAGEMENT AND CONSTRUCTION ASSOCIATED WITH THE NEW CHECKED BAGGAGE INSPECTION SYSTEM PROJECT (CBIS) AT THE HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES**

**WHEREAS**, the City of Atlanta, as owner and operator of the Hartsfield-Jackson Atlanta International Airport, in its quest to gain additional funding for ongoing and innovative projects, applies for offers of grants-in-aid for various projects at the Airport; and

**WHEREAS**, under the authority of the Aviation and Transportation Security Act, Pub. L. 107-71, sections 115 Stat. 597 and 114(m) (1) of 49 U.S.C., and 106(1) (6) and The American Recovery and Reinvestment Act of 2009, Pub. L. 111-5; and

**WHEREAS**, the TSA entered into an Other Transaction Agreement with the City of Atlanta, dated September 21, 2009, to provide funding to the City in an amount not to exceed twenty million and 00/100 dollars (\$20,000,000); and

**WHEREAS**, the City now intends to utilize the reimbursement in the amount of \$20,000,000 for cost associated with the design, management and construction of checked baggage screening project; and

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA** as follows:
