A SUBSTITUTE ORDINANCE BY
FINANCE/EXECUTIVE COMMITTEE

AN ORDINANCE AMENDING THE 2010 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN AN AMOUNT OF FIFTY THOUSAND DOLLARS AND NO CENTS (\$50,000.00) FOR A 'PASS THROUGH' GRANT AWARD FROM THE GEORGIA ENVIRONMENTAL PROTECTION DIVISION FOR THE CONSTRUCTION OF A GREENGRID ROOF SYSTEM AT THE WOODRUFF ARTS CENTER; AND FOR OTHER PURPOSES.

WHEREAS, the Woodruff Arts Center applied for an Environmental Protection Agency 319(h) grant from the Georgia Environmental Protection Division for funds to be used in conjunction with the construction of a GreenGrid Roof System at the Woodruff Arts Center; and

WHEREAS, these federal funds require a 'pass through' agency to disburse the payments; and

WHEREAS, the City of Atlanta ("City") has authorized the Department of Watershed Management to act as the 'pass through' and managing agency for this grant, pursuant to Resolution 09-R-0087 adopted by the Atlanta City Council on January 22, 2009; and

WHEREAS, the City must legislatively anticipate and appropriate grant funds associated with this grant and properly position the said funding for use.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA THAT:

Section 1: That the 2010 (Intergovernmental Grant Fund) Budget is hereby amended as follows:


