

A RESOLUTION APPOINTING ATTORNEY J. C. LOVE, III TO THE BOARD OF DIRECTORS OF THE ATLANTA DEVELOPMENT AUTHORITY AS THE CITY COUNCIL APPOINTEE IN THE BUSINESS CATEGORY FOR A TERM OF FOUR (4) YEARS, SAID TERM TO BEGIN UPON THE APPROVAL OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Development Authority Board of Directors (the Board) was created by Resolution 97-R-0716; and

WHEREAS, pursuant to said Resolution, two members of the seven member Board are appointed by the City Council (Pursuant to Resolution 99-R-0606, the Board was expanded from seven to nine members); and

WHEREAS, said two appointees must have experience in the areas of Business and Real Estate; and

WHEREAS, the City Council appointee serving in the Business Category resigned on August 24, 2009, thereby creating a vacancy; and

WHEREAS, the City Council President and all Council Members were notified of this vacancy and were requested to submit the names of nominees for this position; and


WHEREAS, Council Member, H. Lamar Willis submitted the name of Attorney J. C. Love, III, who is the only nominee submitted for said position; and

WHEREAS, pursuant to City Code Section 2-1852, where there is only one vacancy and one nominee, a resolution shall be prepared naming that individual for appointment to the vacant position and submitted to the committee of purview for its consideration and recommendation, and then forwarded to the Committee on Council, and ultimately, to the full council for action.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:


